(a) Stipulated fixed cost basis (all inclusive) \$ 4500\$

(b) *Additional items found may be turned in to the Insurance Company as a supplement. Contractor's Overhead & Profit may also be submitted as a supplement, if warranted. All supplements approved by the Insurance Company will be additions to the fixed cost above. Owner Initials: JD

(c) Deteriorated decking will be replaced at a cost of \$100.00 per sheet or \$10.00 per linear foot of 1" material. Deteriorated decking will not be on the supplement. If skylights are included in this scope of work, no interior trim, drywall, or paint is included. Owner Initials: JD

(d) Payments shall be due and payable as outlined below:

All retail/cash Roofing Projects are due the day of installation. If you are unable to hand deliver a check to the Project Manager, you are expected to call the office between 7:30 am – 4:30 pm to pay via card over the phone.

For insurance claims, the deductible and upgrades (if applicable) are due the day of installation. If you are unable to hand deliver a check to the Project Manager or Sales Consultant, you are expected to call the office between 7:30 am – 4:30 pm to pay via card over the phone.

For insurance claims, the first check from the Insurance Company is due upon receipt. Many Insurance Companies will list the Mortgage Company as a Payee. It is the owner's responsibility to obtain the endorsement of the Mortgage Company (if applicable).

For insurance claims, recoverable depreciation (if applicable) and supplements (if applicable) are due within 15 days of the final invoice.

Five Points Roofing Company will file supporting documents for recoverable depreciation and supplements (if applicable) at project completion. It is the responsibility of the Owner to follow up with the Insurance Company to ensure that payments are being processed in a timely manner. Owner Initials: _____

The Contractor shall correct, at its' own expense, any defects in the Work due to faulty workmanship pursuant to this Contract and warranty terms. The Owner shall give the Contractor written notice of such defects within seven days of discovery and in any event within the warranty period. The Contractor will convey to Owner any warranties by manufacturers on individual materials, products, or systems supplied by Contractor under this Contract. The Contractor does not warrant labor and/or materials supplied by the Owner or the Owner's subcontractors. The Contractor shall protect the Work, the Owner's property and the property of third parties from damage.

Insurance

Prior to commencing the Work, the Contractor agrees to provide, maintain and pay for insurance during the time the Work is being performed, including commercial general liability in the minimum amount of \$1,000,000 against claims for damages for personal injury or property damage by reason of anything done or not done by the Contractor, its employees or agents, in connection with the performance of this Contract.

Miscellaneous Notes

On average, we will be removing and replacing 7-10 tons of roofing material from your home. Five Points Roofing Company will make the utmost effort to protect the landscaping in the work area. Additionally, removing and replacing a roof system may cause drywall nail pops and/or hairline cracks to the drywall. Five Points Roofing assumes no liability for damaged landscaping or drywall repairs. Owner Initials: JD

Five Points Roofing does not reinstall satellite dishes. You will be responsible for scheduling for this to be done by your service provider. You will be responsible for the cost of any service calls.
